- 6. Ensure all products and certification devices are applied/placed correctly before leaving the plant.
- 7. To ensure all inspections are carried out courteously in cooperation with all staff.

#### **Documentation**

- 1. Ensure documentation is completed in line with the Inspection procedures and systems
- 2. Ensure that the certified plant has all the relevant documentation in relation to HMC products on site.
- 3. Ensure time sheets and monitoring logs are completed and submitted to Head Office on a regular and

- timely basis.
- 4. To be able to keep a track of HMC's certification devices and be able to reconcile/audit its usage and maintenance of associated equipment.
